("RKT") paid a special distribution of \$0.80 per Class A common share to its shareholders of record as of March 20, 2025.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► **The distribution paid on April 3, 2025 is not a dividend for tax purposes and will be treated as nontaxable return of capital to the extent of the stockholders' tax basis. Tax basis in the common shares will be reduced by the amount of the full amount of the distribution. Any amount of the distribution that is not a dividend and in excess of a stockholder's tax basis will be treated as gain for U.S. federal income tax purposes. Stockholders should consult their own legal, financial, or tax advisors to determine the income tax consequences of their specific situation.
