

Hilltop Holdings Ranked Among Top Five Fastest Growing North Texas Public Companies

DALLAS--(BUSINESS WIRE)-- North Texas is home to some of the largest publicly-held companies in the country, including Exxon, AT&T, American Airlines and Tenet Healthcare, to name a few. In its recently published annual ranking of the Top 100 North Texas public companies, the Dallas Business Journal reported Hilltop Holdings Inc. (NYSE: HTH) among the top 50, noting the Company as one of the five fastest growing public companies for the year.

The report, which was compiled from company SEC filings for the calendar year ending Dec. 31, 2015, cited Hilltop Holdings' 43 percent increase in revenue growth from 2014 to 2015, ranking it the area's No. 5 fastest growing public company. Overall, Hilltop Holdings was listed No. 42 among the Top 100 North Texas public companies for 2015, with reported annual revenue of \$1.7 billion. The Company's 2015 revenue increase boosted its ranking over the previous year, where it was listed No. 52 among the Top 100 North Texas public companies.

Separately, earlier this year Forbes ranked Hilltop Holdings No. 5 nationally in its best banks listing of the Top 100 largest publicly-traded banks and thrifts.
